## <Key messages>

- The JCM is one of the effective tools for technology innovation, deployment, and transfer which respond to the needs of developing countries.
- Through technology innovation, deployment and transfer, making use of bilateral schemes such as the JCM and multilateral funds like the Global Environment Facility (GEF), financial sources could be diversified and can contribute to achieve the Nationally Determined Contributions (NDCs) efficiently in an ambitious manner.
- In Indonesia and Viet Nam, the JCM has paved the way for local entity investment and action for low-carbon development – that is to say, we are witnessing a ratcheting up of sustainable

development.
