The Ministry of the Environment, Japan (MOEJ) and the Overseas Environmental Cooperation Center, Japan (OECC) held a side event called "The Joint Crediting Mechanism (JCM) contributions towards achievement of the Nationally Determined Contributions (NDCs)" at the Japan Pavilion during the UNFCCC's 23rd session of the Conference of the Parties (COP23).

<Key messages>

- Good practices realized under the JCM would help to identify appropriate technologies which would contribute ER in the partner countries and achievement of their NDC.
- Taking the JCM projects as a "showcase" further project implementation was facilitated in the field of energy efficiency in a self-sustainable way.
- The governments of JCM partner countries were active in involving their private sectors to share ideas/experiences in project development aiming at further promotion of JCM project implementation.
- The government policy would be important because it could show a signal to the market.

-- Report of UNFCCC Official Side Event on sustainable Pacific Islands --

Since the COP23 was presided over by the Fijian Presidency, greater attention has been given to island countries with regard to climate change. The OECC, together with the Republic of Palau and Okeanos Foundation for the Sea, organized a UNFCCC official side event, which focuses on sustainable Pacific Islands, building upon traditional knowledge as well as advanced technology.

The event was attended by the President of the Republic of Palau, the President of the Republic of the Marshall Islands, the Vice President of Federated States of Micronesia, and entities supporting project development. Pacific leaders showed their keen interest on the regional proposal to the Green Climate Fund (GCF) for the project introducing canoes propelled by fuel-free technologies.

Also, it was reported that renewable energies have been steadily promoted in island countries through the JCM projects, complying with their mitigation goals as stated in their NDCs.

Both projects, one for the GCF project in the pipeline and another for the JCM project which has issued credits, align with the Sustainable Development Goals (SDGs) as well as the typical climate of islands.
