-- News: "Green Hospitals Project" Registered as a JCM Project in Vietnam - The Demonstration Project of Energy Management System in Vietnamese Hospital- (NEDO) --

Under the JCM, "Green Hospital Project" was registered as a JCM project.

This demonstration project has introduced about 1,000 energy efficient inverter air conditioners (ACs) at two state-owned hospitals in Vietnam, along with energy management systems to optimize these ACs efficiently. The project aims to demonstrate and verify these technologies as well as CO2 emission reduction effects, anticipating a 35% energy saving as well as better ventilation of the entire hospital.
