-- Carbon Market Platform Side Event at COP22 --

In June 2016, representatives from Australia, Canada, Chile, EU, France, Germany, Indonesia, Italy, Japan, Korea, New Zealand, Senegal, Switzerland, UK, US and Vietnam, as well as from international organizations, including the International Carbon Action Partnership (ICAP), OECD, the UNFCCC Secretariat and the World Bank met in Tokyo, Japan for the first Strategic Dialogue of the Carbon Market Platform, which was established based on the Leaders' Declaration of the G7 Summit in Germany in June 2015. This event is a follow-up to the successful outcome of the Dialogue.

-- Achievements and Current Progress of the Joint Crediting Mechanism (JCM): Cooperative approaches under Article 6 of the Paris Agreement --

Japan and 16 partner countries are cooperatively developing and implementing the JCM, which is an international market-based mechanism that is currently active. The use of market mechanisms, including the JCM, is articulated under Article 6 of the Paris Agreement, which prescribes the use of emission reductions achieved overseas for national emission reduction targets. The recent progress, achievements and expectations for the implementation of the JCM will be reported and discussed.
